## **RESOLUTION 43-07**

**Whereas,** the Harrison County Commissioners recognize the significance of the Columbus-Pittsburgh Corridor defined as a 160-mile stretch of highway; and

**Whereas,** A coalition of counties has been formed which includes representatives from Franklin, Licking, Muskingum, Coshocton, Tuscarawas, Harrison and Jefferson Counties; and

**Whereas,** We urge the completion of the remaining 25% of the 160-mile corridor and all of its unfinished sections including the Cherry Valley Road/Ohio 16 intersection in Licking County/The Ohio 16 Dresden to Coshocton connector/The Ohio 250 Newcomerstown to Cadiz connector/The U.S. 22 Cadiz to Steubenville connector; and

**Whereas,** The vision of our collective communities realize the economic strength of this corridor upon full completion while also addressing concerns of public safety and relief from the I-70 corridor;

Now Therefore Be It Resolved, by the Board of Commissioners of Harrison County that on this date, joins with each county along the corridor from Columbus to Steubenville in creating and joining as a partner in the creation of the Columbus-Pittsburg Corridor Steering Committee which shall meet monthly for the first four months of inception and quarterly on subsequent occasion until such time that the corridor is completed as a who and open to traffic. Brent Walrath and Phillip Madzia are hereby appointed to serve on the Columbus-Pittsburgh Steering Committee as voting members and are authorized to vote on behalf of Harrison County to adopt bylaws and conduct business hereto forward as a voting member of the organization for a period of four (4) years at which time this Board shall reconsider its representation to the Committee in a manner consistent with the bylaws and structure which are adopted and implemented.
